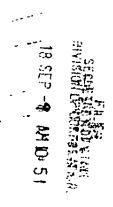

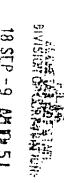

KNOW ALL MEN BY THESE PRESENTS: That Usason Marquez desiring to form a limited liability company for the purposes set forth herein and in conformance with the Florida Limited Liability Company Act, do establish:

- 1. Company Name: That the name of the limited liability company is JAE Marquez Holdings, LLC.
- 2. Duration: That the period of duration of this limited liability company is thirty years from the date of filing hereof with the Florida, unless sooner dissolved as provided by Florida law.
