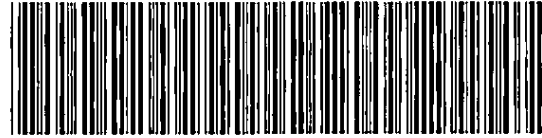

#### ARTICLE VIII - AMENDMENT




