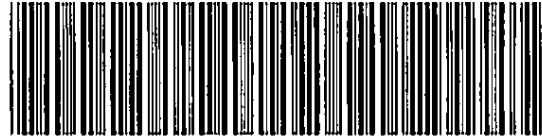

This letter is to serve as record that Katherine Cope and Rebecca Welton do not and have not had any association with Truck Hoes, LLC, and as a recitation of facts surrounding the above mentioned limited liability company (LLC). On September 19th, 2018, Maralyn Reynolds registered an LLC called Truck Hoes, LLC, in her name. She named several people as Managers, including Katherine Cope and Rebecca Welton. Neither Katherine Cope nor Rebecca Welton gave permission for nor were made aware of the filing of said LLC. On October 18th, 2018, both Katherine and Rebecca began receiving mailers for various business offerings addressed to Truck Hoes, LLC. On October 20th, 2018, Katherine Cope researched her name through LexisNexis and found that the Truck Hoes, LLC, was included in her employment record and was registered to Maralyn Reynolds. Several emails and texts were sent to Maralyn Reynolds by both Katherine Cope and Rebecca Welton. These pieces of correspondence were aimed at having Katherine and Rebecca removed as managers of the LLC as they never expressly or implicitly gave permission to Maralyn Reynolds to use their names, and were frankly offended by the facts stated herein. Maralyn Reynolds has yet to file a Dissociation. Katherine Cope and Rebecca Welton refuse and deny any association whatsoever with Truck Hoes, LLC, now, in the past, and in the future based on the events detailed in this letter.
