Dillard, a natural person competent to contract and an authorized representative of 141 Smolian, LLC, hereby presents these Articles of Organization as the Articles of Organization of 141 Smolian, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I – NAME**
