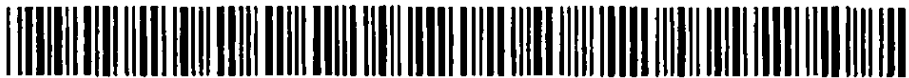


ARTICLE VII – Members


