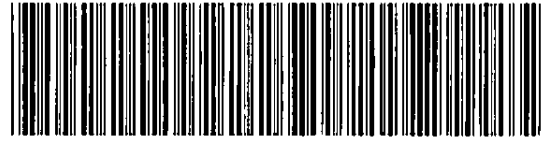

**AMENDED FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE**  
**WITH MINOR CHILDREN, PROPERTY AND OTHER RELIEF**  
**(Amended to correct Husband's name in Paragraph A)**

This cause came before this Court at a final hearing on February 19, 2024, at 10:00 a.m. on the Husband's Petition for Dissolution of Marriage and Other Relief and the Wife's Counter-Petition for Dissolution of Marriage with Children and for Other Relief. The Court, having reviewed the Court file and having heard the testimony of both parties, makes these findings of fact and reaches these conclusions of law:

1. The Court has jurisdiction over the subject matter, the minor children and the parties.
2. The parties were married to each other on August 14, 2004.
3. Both parties have been residents of the State of Florida for more than six (6) months immediately before filing of the Husband's Petition for Dissolution of Marriage and Other Relief and the Wife's Counter-Petition for Dissolution of Marriage with Children and for Other Relief.
4. The parties have two (2) minor or dependent child of this marriage to wit: C.F, female, born 2008 and D.F., III, male, born 2012. The Wife is not currently pregnant.

5. The marriage between the parties is irretrievably broken.
6. The parties have voluntarily entered into a Marital Settlement Agreement and Agreed Parenting Plan, and each has filed the required Financial Affidavit.
7. Based on the testimony of the parties the Court finds that each party entered into the Marital Settlement Agreement and Agreed Parenting Plan freely and voluntarily intending to be bound by same. The parties are ordered to comply with the terms of their Marital Settlement Agreement and Agreed Parenting plan.

**IT IS HEREBY ORDERED AND ADJUDGED** as follows:

A. The bond of marriage between DAVID ALEXANDER FENDER, JR. and TANYA FENDER is dissolved. The parties are restored to the status of being single and unmarried.

B. The Marital Settlement Agreement and Agreed Parenting Plan entered into between the parties and put on the record on February 19, 2024, and signed on March 13 2024, and attached hereto as Exhibit "A" were executed freely and voluntarily by both parties after full disclosure, is in the best interests of the minor children and is approved and incorporated in this Final Judgment and made a part hereof. Despite incorporation into this Final Judgment the Marital Settlement Agreement and Agreed Parenting Plan shall not be merged into this Final Judgment; rather, said documents shall survive this Final Judgment and be binding on the parties for all time and the parties are ordered to comply with its provisions.


C. The parties shall execute and deliver to the other party any documents or instruments that may be reasonably required to accomplish the obligations imposed by this Final Judgment. If either party fails to comply with the provisions of this Final Judgment, this

judgment and the Marital Settlement Agreement and Agreed Parenting Plan, shall constitute an actual grant, assignment, or conveyance of property and rights in such a manner and with such full force and effect that shall be necessary to effectuate the terms of this Final Judgment pursuant to the provisions of Fla. R. Civ. P. Rule 1.570 and Section 61.075(4), Florida Statutes.

D. The Court reserves jurisdiction over the parties, the minor child and subject matter and for all legal and proper purposes, including but not limited to the entry of QDRO's, enforcement of the terms of this Judgment, modification of this Judgment, for the entry of any necessary Orders to carry out the terms contained in the Marital Settlement Agreement, Agreed Parenting Plan and this Final Judgment, for purposes of, but not limited to, enforcement and for all legal and proper purposes.

E. The Wife shall be restored to her former name of: TANYA MARIE ROBERTS.
