
Pursuant to the provisions of Section 605.0202, Florida Statutes, **Wray's Dirt, LLC**, a Florida limited liability company (the "Company"), adopts the following amendment (the "Amendment") to its Articles of Organization:

1. The name of the Company is **Wray's Dirt, LLC**.
2. The Articles of Organization were filed on September 21, 2018, and assigned document number L18000223775.
3. Article VI of the Articles of Organization of the Company is hereby amended by deleting it in its entirety and replacing it with the following:

"ARTICLE VI – MANAGEMENT
