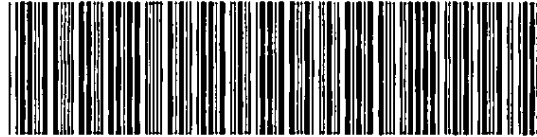

Delaware LLC: Island Hoppers, LLC

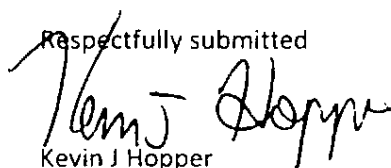
Florida LLC: Island Hopper of Pasadena, LLC
