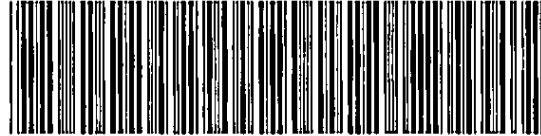



OF


