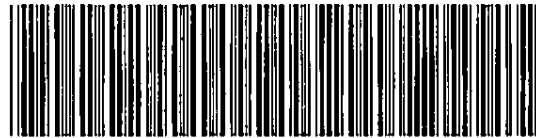

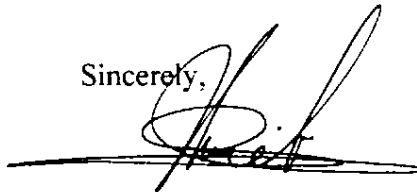

**ARTICLE I : NAME**

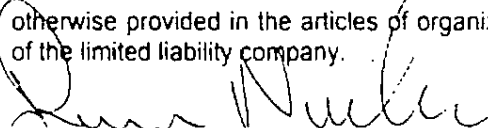

6. Amend to change the new registered office address to 245 191<sup>st</sup> Terrace, Sunny Isles Beach, FL 33160.

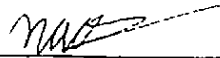

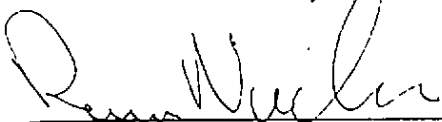
