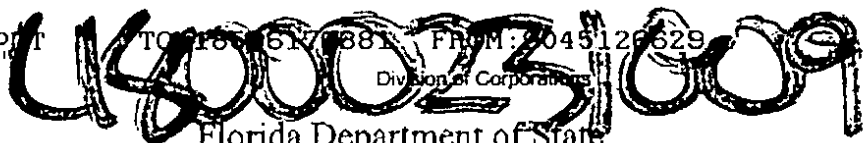

**ARTICLE I




