**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF ORGANIZATION
OF
TH-SEE LLC**

(a Florida limited liability company)

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), TH-SEE LLC, a Florida limited liability company (the "Company"), adopts the following Articles of Amendment to the Articles of Organization:

1. The name of the company is TH-SEE LLC.

3. Article I of the Company's Articles of Organization is hereby deleted and replaced in its entirety with the following new Article I:
