Ford, competent to contract and an authorized representative of KMF FLORIDA, LLC, hereby presents these Articles of Organization as the Articles of Organization of KMF FLORIDA, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is KMF FLORIDA, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The initial mailing address and principal address of the Company is 513 East Romana Street, Pensacola, Florida 32502. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

**ARTICLE III - PURPOSE AND POWERS**

The initial registered agent of the Company is Megan F. Fry, and the initial address for that registered agent is 125 E. Intendencia Street, Pensacola, Florida 32502.


**ARTICLE VI - MANAGEMENT**


