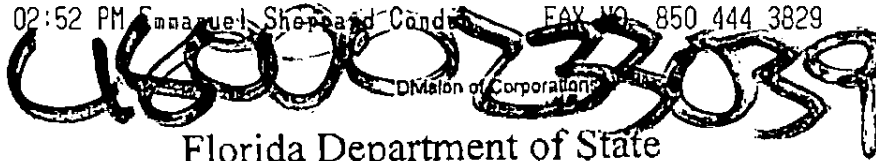

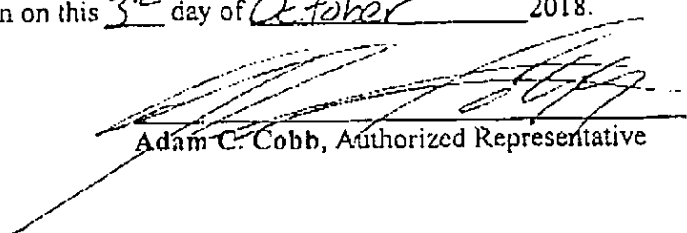
ARTICLE VIII – Additional Members
