The undersigned, being a natural person of at least 18 years of age and acting as the Organizer of the Limited Liability Company hereby being formed under the Florida Revised Limited Liability Company Act and the Professional Service Corporation and Limited Liability Company Act, does hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Professional Limited Liability Company is:

SPECIAL EDUCATION LAW AND ADVOCACY, PLLC

SECOND: The term of existence of the Limited Liability Company shall be perpetual.

THIRD: The purposes of the Limited Liability Company are to provide legal services as defined by the Supreme Court of Florida and The Florida Bar, to include any and all lawful business of a professional limited liability company as otherwise permitted by Chapter 621, Fla.Stat.; to enter into and perform contracts and agreements of any kind necessary to, in connection with or incidental to the business of the Limited Liability Company; and to carry on any other activities necessary to, in connection with or incidental to the foregoing, as the Manager in his or her discretion may deem desirable. The legal services are limited to those within the State of Florida or wherever any Member is eligible to practice law or as may be permitted by other jurisdictions.

FOURTH: The mailing address and street address of the initial registered agent of the Limited Liability Company in Florida is 2602 West Cypress Street, Tampa, Florida 33609, and the name of the initial registered agent of the Limited Liability Company to whom process may be sent in Florida at that address is Alison Allman, Esq.

Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 605, F.S.

FIFTH: The mailing address and principal office of the Limited Liability Company is 2602 West Cypress Street, Tampa, Florida 33609.

SIXTH: The Limited Liability Company is to be managed by the Manager. The name and address of the initial Manager are: Allison Allman, Esq., having an address at 2602 West Cypress Street, Tampa, Florida 33609.

SEVENTH: The total amount of cash (and a description and agreed value of any property other than cash) contributed to the Limited Liability Company, as capital, by the sole Member is ten Dollars (\$10.00). The allocations and distributions of the Limited Liability Company shall be made in proportion to the Members' Percentage Interests.

EIGHTH: Additional capital contributions may be made at such times and in such amounts as may hereafter may be agreed by the unanimous vote of the Members. No additional capital contributions have been agreed to by the Members at this time.


NINTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members.

TENTH: If there later are more than one Members, the remaining Members of the Limited Liability Company, by the unanimous vote or consent of the Members (other than the Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.

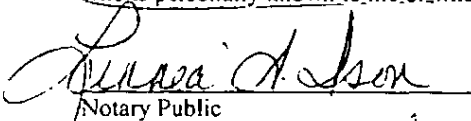
TWELFTH: None of the Members of the Limited Liability Company are liable for payment of any debt, obligation or other liability of the Limited Liability Company.

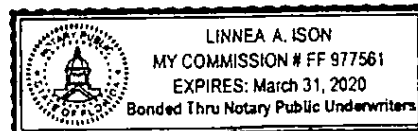
