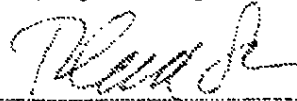

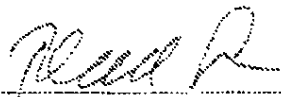
ARTICLE IV - MANAGEMENT
