**SECOND AMENDMENT TO ARTICLES OF ORGANIZATION
OF

1. Name and Document Number. The name of the Company is currently ST CM LLC and its document number on file with the Division of Corporations of the Florida Department of State is 1.18000235831.

2. Amendment to Article I. Article I of the Articles of Organization is hereby amended in its entirety to read as follows:

The name of the limited liability company is STO CM LLC (the "Company").

3. Effective Date of Amendment. This Amendment was adopted and shall be effective on December 6, 2018.

4. Effect of Amendment. The Articles of Organization shall remain in full force and effect except as expressly modified by this Amendment.
