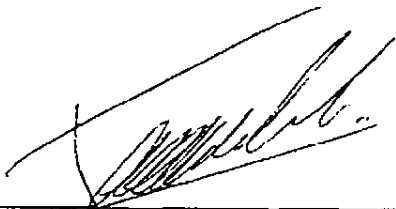
ARTICLE VI. PURPOSE

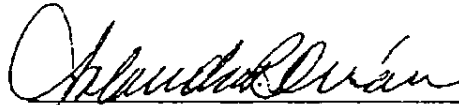

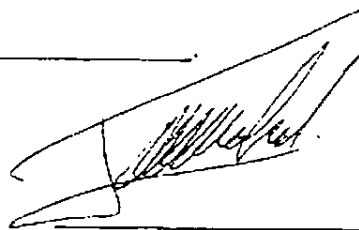
