

# ARTICLES OF ORGANIZATION OF DENISE MORRISON & ASSOCIATES LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and fless the following Articles of Organization.

## ARTICLE I - NAME

The name of the limited liability company shall be DENISE MORRISON & ASSOCIATES LLC (the "Company").

#### ARTICLE II - ADDRESS

### ARTICLE VI - LIMITATION ON AGENCY AUTHORITY OF MEMBERS

Pursuant to Chapter 605, Florida Statutes, no member of the Company shall be an agent of the Company for the purpose of its business solely by virtue of being a member, and no member may bind the Company by taking any action solely by virtue of being a member.

## ARTICLE VII - WRITTEN OPERATING AGREEMENT

Any operating agreement entered into by the members of the Company, and any amendments or restatements thereof, shall be in writing. No oral agreement among any of the members or managers of the company shall be deemed or construed to constitute any portion of, or otherwise affect the

interpretation of, any written operating agreement of the Company, as amended and in existence from time to time.
