The name of the limited liability company is AKSALA WEALTH ADVISORS, LLC.

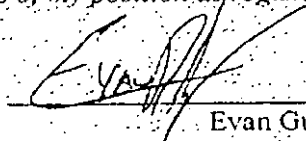
ARTICLE II. ADDRESS

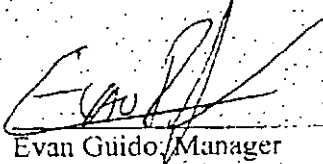
