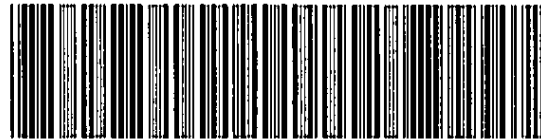

ARTICLES OF DISSOLUTION

Pursuant to relevant section of Chapter 605 of the Florida Statutes, this Florida limited liability company submits the following articles of dissolution:

**ARTICLE I
NAME**

The name of the limited liability company filing these Articles of Dissolution is HLR TWELVE OAKS, LLC

**ARTICLE II
ORIGINALLY FILED ARTICLES**

The Articles of Organization of HLR TWELVE OAKS, LLC (the "Company") were filed on October 10, 2016. The Document Number for the Company is L18000240335.

**ARTICLE III
DATE OF APPROVAL OF DISSOLUTION**

The Members of the Company held a special meeting of the Members on April 9, 2021 at which a quorum was present. At the meeting it was determined that it was in the best interests of the Company to dissolve, to settle and close the Company's activities to marshal the Company's assets, to distribute the Company's assets to pay all known creditors, and to distribute all of the Company's remaining assets to the Members. No continuing operations of the Company will occur following the Effective Date as defined below.

The Dissolution of the Company was approved on April 9, 2021 by unanimous decision of the Members which was sufficient for passage of the Articles of Dissolution under the terms of the Operating Agreement. The effective date for the Dissolution is April 30, 2021 (the "Effective Date").

**ARTICLE IV
PROVISION FOR LIABILITIES**

The Company has no liabilities other than liabilities incurred in the ordinary course of business as of the approval date and no liabilities will be incurred prior to the Effective Date. There are no suits pending against the Company in any court.

ARTICLE V
NOTICE OF DISSOLUTION OF LIMITED LIABILITY COMPANY
CLAIMS OF UNKNOWN CREDITORS

HLR TWELVE OAKS, LLC will dissolve under these Articles of Dissolution as of the Effective Date. Any claims against the Company must be made in writing and delivered to the Company at the following address: Mark H. Muller, P.A., 5150 Tamiami Trail North, Suite 303, Naples, Florida 34103.

Any Claimant must provide to the Company in writing: (i) the nature and date of the Claim sufficient for the Company to understand the claim and how and to whom to respond; (ii) the relief requested, if any; (iii) a copy of any contract or source documentation associated with the claim; and (iv) contact information of the claimant(s) and/or their attorneys, if represented.

Any claim against the company is barred unless an action to enforce the claim is commenced within 4 years after the filing of the notice.

The signature of the Manager of the Company below represents that the approval of the dissolution of the Company has been agreed to by the unanimous vote of the Members necessary to approve the dissolution at a special meeting of the Company as required by the Operating Agreement of the Company:
