ARTICLE I NAME

ARTICLE II ORIGINALLY FILED ARTICLES

The Articles of Organization of HLR TWELVE OAKS, LLC (the "Company") were filed on October 10, 2016. The Document Number for the Company is L18000240335.

ARTICLE III DATE OF APPROVAL OF DISSOLUTION

The Members of the Company held a special meeting of the Members on April 9, 2021 at which a quorum was present.
