person filing both and will permanently dissolve the previous filing.

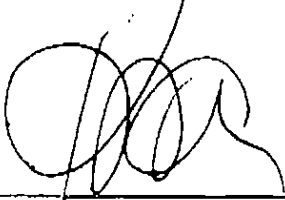
