
To Whom It May Concern:

Pursuant to my telephone conference with one of your representatives with regard to your Tracking Number 000319398870 which is attached hereto stating that the above-referenced name is unavailable, the following should clarify matters:

On September 26, 2018, I filed Articles of Incorporation for Veronica Crego-Flores, P.A. which are attached hereto for your information. When I applied for an EIN on the IRS site, one could not be issued online. The problem was that there had been a Veronica Crego-Flores, P.A., which is now inactive but which the IRS never closed out its EIN.
