

## ARTICLES OF ORGANIZATION OF COMAC OF FLORIDA, LLC

The undersigned, Robert A. Melntosh, a natural person competent to contract and an authorized representative of COMAC of Florida, LLC, hereby presents these Articles of Organization as the Articles of Organization of COMAC of Florida, LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

#### ARTICLE I - NAME
