**ARTICLES OF ORGANIZATION

ARTICLE I - NAME

The name of the limited liability company is Tier One Life Insurance, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS


