ARTICLES OF ORGANIZATION
OF
CPD FOODS, LLC

The undersigned person, acting as the organizer of CPD FOODS, LLC, under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is:

CPD FOODS, LLC

ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the company will commence as of **November 1, 2018**, and the existence of the company shall be perpetual.

ARTICLE III - PURPOSE

The company may transact any or all lawful business for which a limited liability company may be organized under the Florida Limited Liability Company Act.

ARTICLE IV - INITIAL REGISTERED AGENT AND OFFICE

ARTICLE X - TERMINATION OF MEMBERSHIP INTEREST




