The undersigned authorized representative executes these Articles of Organization to form a limited liability company under the Florida Revised Limited Liability Company Act.

ARTICLE I. NAME

The name of the limited liability company is: Michaelson's Home Services, LLC.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The existence of the limited liability company will commence at the time and on the date these Articles of Organization are filed with the Florida Department of State.


