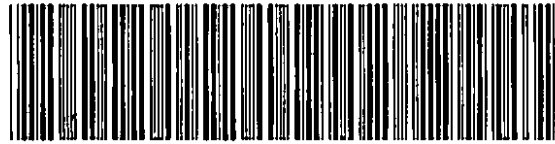





The Company is to be a manager-managed Company. The initial Manager of the company is Lawrence Mann.


ARTICLE V
