

## ARTICLES OF ORGANIZATION OF BANJO LAKE VILLAS, LLC

- 1. Name. The name of this limited liability company is BANJO LAKE VILLAS, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida (the "Act").
