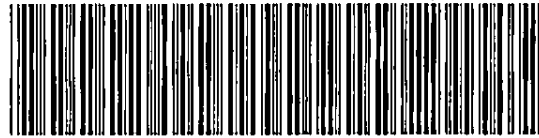



**ARTICLES OF ORGANIZATION
OF
BANJO LAKE VILLAS, LLC**

1. Name. The name of this limited liability company is **BANJO LAKE VILLAS, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida (the "Act").

2. Duration. The Company's existence shall be perpetual, and the effective date of commencement of the Company's existence shall be November 8, 2018.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 2550 Lake Ellen Drive, Tampa, Florida 33618.


