ARTICLES OF ORGANIZATION

SECRETARY OF SIM-

The undersigned, acting as an authorized representative of the initial members of the above captioned Limited Liability Company, under the provisions of the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*, adopts the following Articles of Organization:

ARTICLE I NAME & ADDRESS

The name of this limited liability company is AVG BRANDON LLC (the "Company") and its principal office and mailing address is 14604 Galt Lake Drive, Tampa, Florida 33626.

ARTICLE II EFFECTIVE DATE

The Company shall commence its existence upon the filing of these Articles of Organization with the Florida Secretary of State.

ARTICLE III INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Company shall be 1200 South Pine Island Road, Plantation, Florida 33324, and the initial registered agent of the Company at such address is C T CORPORATION SYSTEM.

ARTICLE IV OPERATING AGREEMENT

The power to adopt, after, amend or repeal an Operating Agreement governing the operation of the Company shall be vested in its members.

ARTICLE V MANAGEMENT OF THE COMPANY

The Company shall be a member-managed Company and shall be managed by its sole member, AVG INTERMEDIATE HOLDINGS LLC.

ARTICLE VI INDEMNIFICATION

If the criteria set forth in §605.0408, Florida Statutes, or any successor statute, and any criteria set forth in the Company's Operating Agreement have been met, then the Company shall indemnify any manager or member, or former manager or member, his or its personal representatives, devisees or heirs, in the manner and to the extent contemplated by §605.0408, Florida Statutes.
