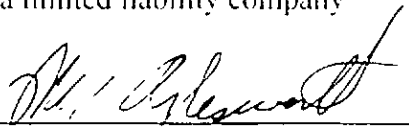

CERTIFICATE OF CONVERSION

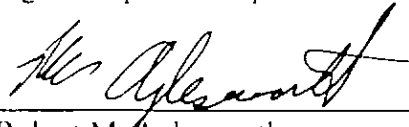
