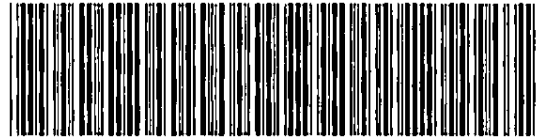

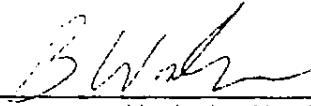

ARTICLES OF ORGANIZATION

THIS IS TO CERTIFY:

That the undersigned, Brandon Walsh, whose post office address is 8741 Mylander Lane, Towson, MD 21286, acting as organizer, being duly authorized to so do, does hereby form a Maryland limited liability company pursuant to §4A-204 and §4A-206 of the Corporations and Associations Article of the Annotated Code of Maryland.

1. **Name.** The name of the LLC (which is hereinafter called the "Company") shall be "**WALSH MEDIA LLC**".

2. **Purpose.** The Company is formed for the purpose of engaging in and conducting all and every kind of lawful business, including, but not limited to, creating, producing, and publishing videos and other social media content.

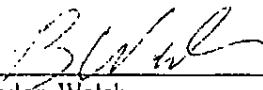
3. **Principal Office and Resident Agent.** The address of the principal office of the Company is 8741 Mylander Lane, Towson, MD 21286. The resident agent of the Company is Lauren Ades who is a citizen of Maryland and resides therein, and her address is 901 Dulancy Valley Road, Suite 500, Towson, MD 21204.

4. **Limitation on Members' Authority; Written Operating Agreement.** The authority of members of the Company to act for the Company solely by virtue of their being members is limited as follows: (i) no member of the Company is an agent of the Company solely by virtue of being a member, and (ii) no member has authority to act for the Company solely by virtue of being a member. The rights and obligations of the members of the Company shall be governed by a written Operating Agreement of the Company (the "Agreement").

5. **Restrictions on Transfer.** The transferability of membership interests in the Company is limited by the terms and conditions of the Agreement to which reference is hereby made regarding the terms and conditions under which transfers are permitted. Additionally, the interests in the Company have not been registered pursuant to the provisions of the Securities Act of 1933 or the Maryland Securities Act. Consequently, the sale, transfer, pledge, hypothecation or other disposition of any interests in the Company is restricted and may not be accomplished except in accordance with the Agreement and/or a properly filed registration statement under applicable securities law.

6. **Definitions.** Throughout these Articles of Organization, any word or words that are defined in the Maryland Limited Liability Company Act, as amended from time to time (the "Act"), shall have the same meaning as provided in the Act.
