ARTICLE VII. OPERATING AGREEMENT

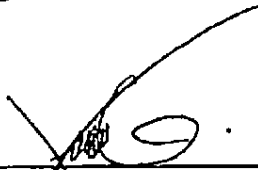

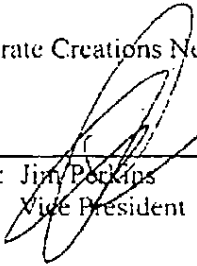
