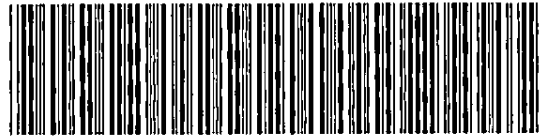

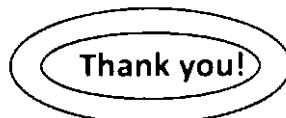

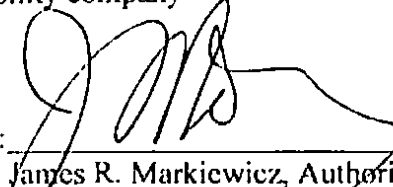
1. The name of the "Other Business Entity" immediately prior to the filing of the Articles of Conversion is Markiewicz Family, LLC.

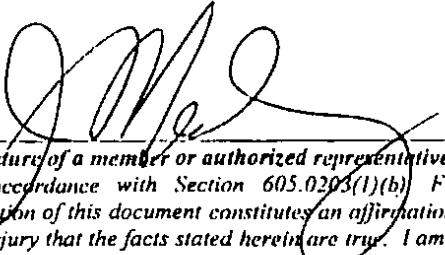
