ARTICLE VIII - AMENDMENT

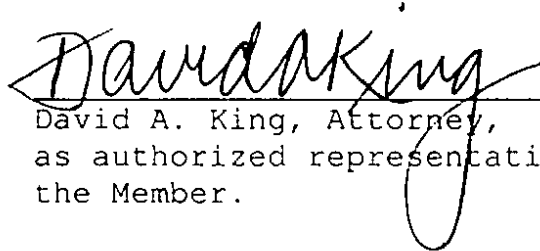

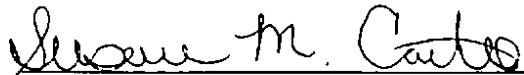
