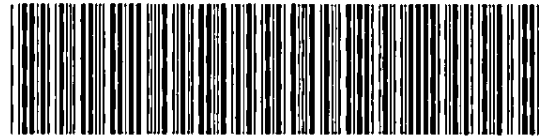

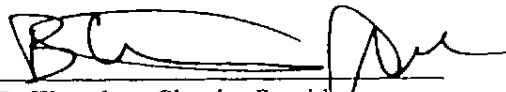

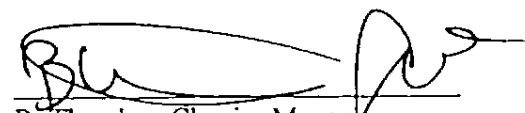
1. The name of the Corporation immediately prior to the filing of these Articles of Conversion is Dawn Star Inc.

The street address and the mailing address of the principal office of the Company are 367 High Bluff Road, Middletown, Virginia 22645.

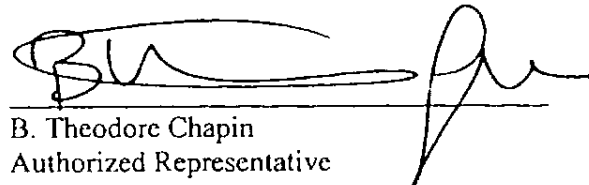
ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

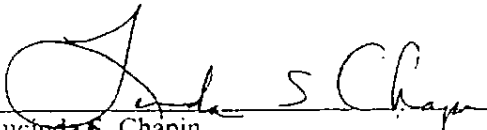
