**ARTICLES OF ORGANIZATION  
OF  
HADLEY LOFT, LLC**

The undersigned, pursuant to the provisions of the Florida Revised Limited Liability Company Act, Chapter 605 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, sets forth the following:

**ARTICLE I - NAME**

The name of this limited liability company is **HADLEY LOFT, LLC** (the "Company").
