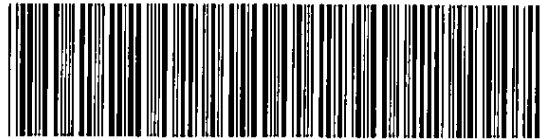

The name of the Company's initial registered agent in Florida is Neison. The address of the Company's registered office in Florida is Flora Vista Ave, Tampa, Florida 33604.




