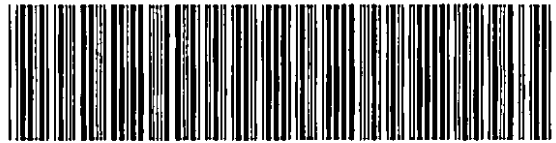

4. The date of filing of the dissolution of the Company is February 8, 2021.


