ARTICLE I


**ARTICLE VII

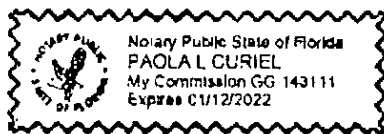
