ARTICLES OF ORGANIZATION*of***MURRAY HILL PLAZA, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I**NAME**

The name of the limited liability company shall be Murray Hill Plaza, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 4237 Salisbury Road North, Suite 212, Jacksonville, Florida 32216.

ARTICLE II**PURPOSES AND POWERS**

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.


ARTICLE VI


