ARTICLE IX Written Operating Agreement

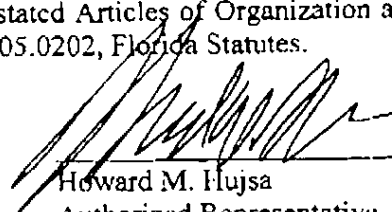
