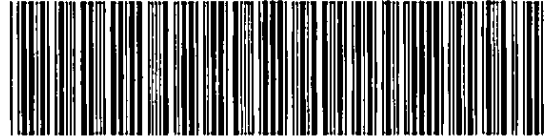

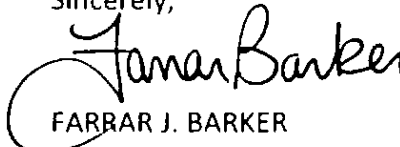

The undersigned, Dana Saffel, a natural person competent to contract and an authorized representative of SolutionsRX Management Group, LLC, hereby presents these Articles of Organization as the Articles of Organization of SolutionsRX Management Group, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

The Company shall be managed by one or more managers in accordance with the terms of the Operating Agreement for the Company. The names and addresses of the initial managers of the Company are as follows:

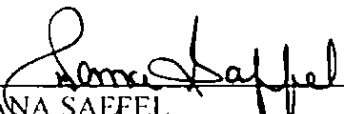

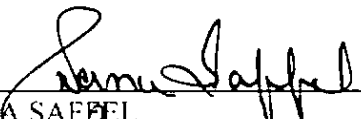
