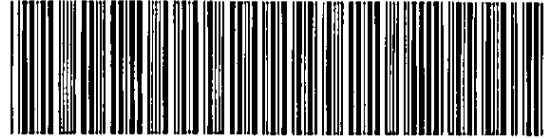

**FIRST:** The Articles of Organization for the Company were filed on December 10, 2018, and assigned document number L18000284163.


