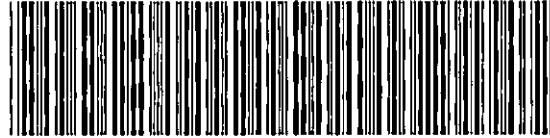

ARTICLES OF CONVERSION



5. The effective date of the filing of these Articles of Conversion shall be January 1, 2019.






