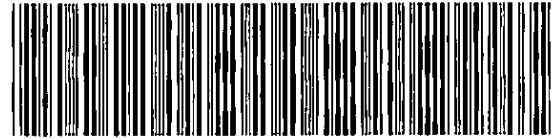

adopt new provisions, and the method for same shall be contained in the Operating Agreement of the Company.


