ARTICLES OF ORGANIZATION

The Articles of Organization of Madness Sunset 19 LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on December 20, 2018; effective January 1, 2019 under Document Number L18000291532, which articles of organization were amended on January 7, 2019. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the Articles of Organization and Amendment to the Articles of Organization are hereby amended and restated in their entirety to read as follows:

ARTICLE I - NAME

The mailing address and the street address of the principal office of the Company is 6624 Gates Pointe Way, Riverview, Florida 33578.


ARTICLE III - REGISTERED OFFICE AND AGENT


