ARTICLE III – REGISTERED AGENT

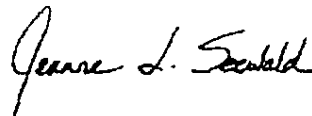

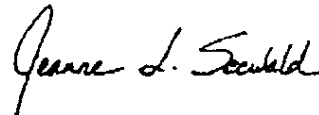
